*“Pedophilia and the brain: What do we know? What do we do?”*

Brain scanning stands poised to revolutionize our understanding of pedophilia and hebephilia. Although the potential importance of MRI technologies is widely recognized, their results and implications are not yet widely discussed outside the scientific arena. This presentation is aimed at public viewers without any background in neuroscience or sex research, to help in understanding the current state of the science and its implications for how we think about pedophilia in clinical, ethical, and prevention efforts. This presentation will not only make the current science accessible to audience members, but will also help professionals critically evaluate claims made about the implications of MRI findings for policy, practice, and science.

*Dr. James Cantor is a clinical psychologist and sexual behavior scientist. For the past 20 years, he has been studying the nature and causes of sexual interests from relatively familiar ones—such as heterosexuality and homosexuality, transsexuality, and asexuality—to rare and exotic phenomena. Highly published, Dr. Cantor regularly appears in the media internationally to discuss how society can better apply science to prevent sexual abuse and provide more ethical and more effective treatment for people with atypical sexual interests. Dr. Cantor is a Senior Scientist at the Centre for Addiction and Mental Health (CAMH) in Toronto, Associate Professor of Psychiatry on the University of Toronto Faculty of Medicine, and his is the past Editor of the Sexual Abuse, the top research journal in this field and the official journal for the Association for the Treatment of Sexual Abusers.
