Information about the Bibliography

Expanding from the previous work of Smith, Craig, Loose, Brodus, and Kimmelman (2002) and Craig, Smith, Hayler, and Pardee (1999), the authors compiled a bibliography of literature on juvenile sex offenders, including scholarly research and literature, while adding a new section on governmental research and other non-peer reviewed literature. Additional changes were made to the original work that included a reduction in the number of categories through combining like categories (i.e., sexuality and sexual development) and elimination of pre-1982 references, as well as the elimination of any materials not focused specifically on juvenile sex offenders (i.e., adult sex offender references) and the elimination of unpublished works (i.e., dissertations, theses) to promote accessibility of the references. New entries were added that included research and literature published from 2002 through the first quarter of 2007. The additions to the bibliography were compiled through conducting a comprehensive search of several on-line research databases from 2003 – March, 2007 (including but not limited to

CINAHL, EBSCO, FirstSearch, LegalTrac, SECIUS, and WorldCat) and from utilizing references in existing publications. The current bibliography contains a total of 657 juvenile sex offender publications with 515 scholarly journal articles, 31 reports, 51 books, and 60 publications from governmental or other non-peer-reviewed sources.

The bibliography was developed between January, 2007 – April, 2007. The development of the bibliography was funded by a Center for Sex Offender Management grant and compiled by Nancy G. Calley, Ph.D., LPC, Spectrum Human Services, Inc. & Affiliated Companies & the University of Detroit Mercy and Beverly Reppert, MSLS, Reference Librarian, University of Detroit Mercy.
