What's Next: Post Treatment Measures for High Needs Individuals with Intellectual Disabilities

Since 1998, Vita Community Living Services has been providing treatment intervention to individuals with an Intellectual Disabilities and a history of sexual offending behavior. Vita offers a multidisciplinary approach to treatment involving partnerships with other community agency's, hospitals and facilities in order to continue to provide and develop services that are not only focused on best practices, but also on progressive, effective, forward-looking service. Treatment occurs in a highly structured, secure setting which includes significant precautionary measures, and high staffing levels. Success rates for these men are extremely high while in the program, but then the question arises: "what's next?"

It is well known that individuals with Intellectual Disabilities can and do benefit from treatment for sexually offensive behaviour. The question then becomes, what happens after treatment for those who while successful in a structured therapeutic setting continues to need exactly those structures to continue their success and maintain safety for those in their communities. The transition from a highly structured secure residential treatment program into a community-based support system can be highly challenging, especially in a sector that is underfunded and at times ill-prepared to support these individuals (Brenner 2014).

The focus of this presentation will be the development of long-term maintenance programs for intellectually delayed offenders. How to build programs that are structured and supportive of the needs of the individual post treatment, but with a focus on supporting and maintaining skills while becoming members of their communities. Particular focus will be on staff training, physical precautions and the importance of collaboration between clinical supports, residential support and management.
